APRIL 18 - 20, 2008

Welcome to the 7th Annual Parkersburg Obedience Training Club Spring Agility Trials... we hope you enjoy yourselves and that we see you again in October (check www.furrydogs.com for updates to this and future trials)! You'll find confirmations for your entries included in this mailing; please review them carefully and report any errors or missing information to the Secretary ASAP. Note that move-ups are due by **6pm on Monday, April 14th**.

Below you'll find ring assignments and running schedule for the weekend. Please plan your arrival accordingly (allow 5-10 minutes to get to the show site from I-77); also those of you who generously volunteered to work will receive a worker assignment schedule so that you can plan your weekend.

Check-in: Those exhibitors who sent in all their height cards and have no other special check-in requirements will find their armbands at the check-in table. If you do not find your armbands at the table, please see the Trial Secretary (this will be true for anyone who did not send a height card for one or more of their dogs) or Registration attendant at the trial.

Measuring: If you did not submit a copy of a jump height card (indicated on your confirmation page), please bring your card to the check-in table or be prepared to have your dog measured **prior to running** - please plan to allow some extra time to do this prior to the start of judging. *Friday, Saturday & Sunday, we will have a VMO present - all dogs w/o a height card MUST be measured.* He will be measuring at 9:30 am on Friday and 7:30 am Saturday/Sunday, and at other times as his own trial schedule allows.

- ****Lunch breaks to be taken at the judges' discretion****
- STD & JWW: Novice B, A, and Preferred will run together by height in that order, as will Open & Open Pref; and ExB, ExBP, ExA & ExAP.
- Running order: 26" to 4" all three days
- Excellent STD/JWW will be split into 3 walkthroughs (26-20; 16; 12-4); at a minimum, we'll walk 26-20 then run 26-20; then walk 16, walk 12-4, run 16, run 12-4. Walk-throughs may be further split. FAST will not be split by height, nor will Novice or Open STD/JWW.

Show Site Info and Directions:

Food and indoor restrooms will be available at the show site.

Overnight RV parking & camping at the show site is permitted; electric hookups available at \$20/day; please contact Trial Chairperson if questions. No dogs may be left unsupervised overnight at the show site, but crates/ex-pens/shelters may be left at the owner's risk. We will be setting up on Thursday evening; please plan to be there by 7:30pm if you plan to set up your equipment that evening.



There is plenty of covered crating space; however, indoor space may be limited. Please see the photos (www.furrydogs.com) of the "covered porch" area surrounding the building.

Please clean up after your dogs! This show is being held at a county fairground. **No dogs are allowed in the restrooms!**

Directions: From N or S, take I-77 to Exit 1 (Marietta), then westward on SR-7 South (Newport Pike) for ~1.1 miles; bear left at the 3-way intersection as road becomes Greene St (SR-60) & continue ~0.5mi to Front St (Hotel Lafayette will be straight ahead). Turn right onto Front; stay in right lane & continue straight for ~1.6 mi; the Fairgrounds will be on your left.

Hotel Info: Many area hotels accept well-mannered dogs and handlers; some may charge additional fees for pets, so please call ahead to verify acceptance. Please clean up after your pets at the hotels! They are considered extensions of the show site, and we have requested these properties to notify us of any problems so that appropriate actions may be taken. The Best Western is closest to the show site; Parkersburg hotels are the

farthest (although only ~10 minutes farther). A list is available in the premium or on my website at www.furrydogs.com under Trial Site Info.
