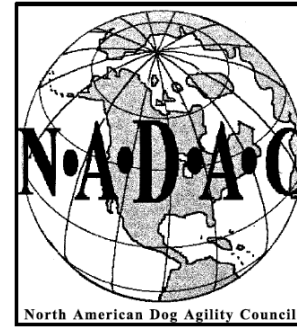

NOTICE TO EXHIBITORS

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations in the current Exhibitors Handbook and agree to abide by all rules in effect at the time of the trial. A copy of the current Exhibitors Handbook may be downloaded free from the NADAC web site: www.nadac.com. Exhibitors may request a hardcopy of the current Exhibitors Handbook by sending \$5.00 to: North American Dog Agility Council, POB 1206, Colbert, OK 74733; info@nadac.com

Dogs must be registered and have a valid registration number before entries will be accepted. You can register your dog online at www.nadac.com and receive a registration number immediately

The Current Jump Height Table, Breed Exemption List, description of classes, levels, and divisions are included in the current Exhibitors Handbook.

All obstacles conform to current NADAC specifications as listed at www.nadac.com.

THE MANAGEMENT will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result was by accident or any other cause. It is distinctly understood that every dog at this event is in the care, custody and control of his owner or handler during the entire time the dog is on the show premises. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such case, no refund of fees paid will be made.

The organizing committee may refuse any entry on the basis expressly provided through NADAC rules and regulations or guidelines established by the NADAC board of directors. Anyone not currently in good standing with NADAC will not be allowed entry into the trial.

IMPORTANT! Please check your dog's NADAC registration number on your trial confirmation as soon as you receive it; also, please check the copy of the results posted at the trial. You should report any errors to the Trial Secretary immediately.

NADAC records trial results as they are submitted by the host clubs/groups. The individual trial results submitted by the club are uploaded to the files section of the NADACagility@yahoo.com list within two weeks after the NADAC office receives them from the club. The trial results will remain on the list for at least thirty (30) days. Please accept the responsibility to review those results, and check that your registration number and qualifying points, as reported by the club, are correct. You can join the www.NADACagility@yahoo.com list and set your settings to "no mail". You will be able to view trial results and check for any possible discrepancies, without receiving list mail. If you find an error in the reporting of your dog's qualifying points or registration number, please contact the host club. The host club is responsible for correcting any errors and informing NADAC.

Levels. Points earned at a higher level of a class, prior to the completion of the lower level title, will not be banked by NADAC for future use. If a dog earns points in a level of a class that they are not eligible to title in, those points will not be added to the dog's records.

Non-Jumping classes – Veteran or Disabled Handler: Handlers who are 60 years or older, or who have a disability that restricts mobility, may choose to enter the non-jumping classes as a Vet Handler and receive 10% more standard course time. This option is for Vet/Disabled handlers in the non-jumping classes only. The Vet/Disabled Handler division is designed for handlers who, due to age or impairment, are mobility limited and need extra time to guide their canine partners through an agility course. When entering as a Vet/Disabled Handler, you must enter all dogs in all classes for the entire trial in this Division and must jump 4" lower than your Proficient, Standard Division jump height requires. In the non-jumping classes, dogs will be scored and placed with their Standard Division jump height.

MOVEUPS

Pre-trial Moveups: If you complete a title prior to the trial, you may move up to the next level for the entire trial. Pre-trial moveups must be received by the trial secretary no later than 6pm on Monday, February 7th. Requests may be submitted on paper or by email.

Weekend Moveups: There will be no same day move-ups; however, if you title on Saturday, you may move up the next level on Sunday. Move-up forms will be available at our hospitality table (or see show secretary). Completed forms must be in the designated place at the end of the day Saturday.

ENTRY CHANGES

Accepted entries may be changed prior to February 7, 2011 at 6:00pm. Send change requests to the Trial Secretary (email is preferred). The change request must identify dog, handler, dog's NADAC number, current classes entered, and the requested change. **Any changes made after the Entry Change date will cost \$5.00 per change** regardless of who is at fault so please check your confirmation carefully! Saturday to Sunday move-ups do not constitute an entry change and will be happily accommodated!

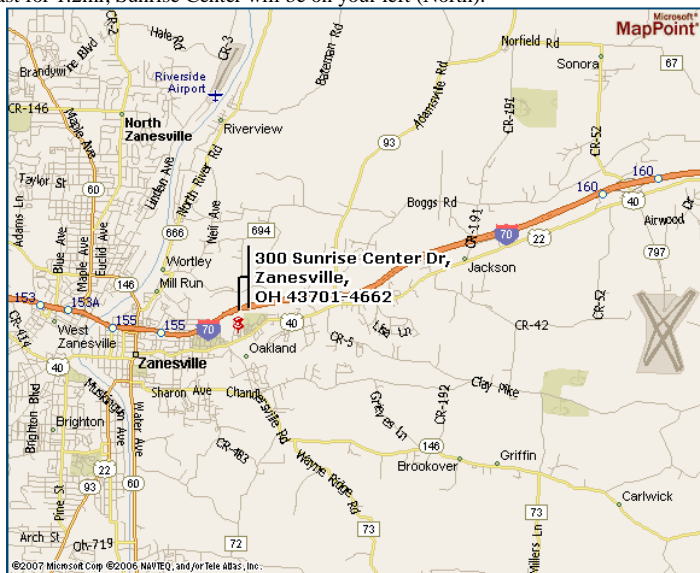

DIRECTIONS TO SHOW SITE

Fieldhouse Family Sports & Wellness Center, 300 Sunrise Ctr, Zanesville OH 43830

From the East, take I-70 to Exit 157; turn left (South) on SR-93 for 0.2mi; then turn right (West) onto US-22/US-40. Travel West for 1.1mi; Sunrise Center will be on your right (North).

From the West, take I-70 to Exit 155 for OH-60S/OH-146E. Bear left onto Elberon Ave; go 0.1mi, and turn right (South) onto OH-60S/146E. Travel 0.2mi and turn left (East) onto US-22/US-40. Travel East for 1.2mi; Sunrise Center will be on your left (North).



Overnight RV parking & camping at the show site is permitted; there are plenty of spots available at no fee. No electric or water hookups available. Contact the Trial Chair if you have specific questions. No dogs may be left unsupervised overnight at the show site, but crates/expens/shelters may be left at the owner's risk.

Please clean up after your dogs! This show is being held at private sports facility. No dogs are allowed in the restrooms!

FOOD

Concessions will be available on-site. There are also many restaurants within a few minutes' drive.

VENDORS

Vendors are welcome! Vending fee is \$25 for the entire weekend. Please contact the Trial Chair for more information. Space is limited, first-come, first-served.

CLUB POLICIES

- All dogs must be on leash when not competing in the ring.
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, an act of God, public emergency, and act of public enemy, or any other cause beyond the control of the organizing committee.
- **Checks not honored by the bank do not constitute a valid entry fee. There will be a \$20 service charge for bank returned checks.**
- Handlers with more than one dog in a class will be separated if possible.
- All handlers for a given class should be present at ringside at least one-half hour prior to the start of the scheduled classes for walk through and briefing. Any dog and handler not present when they are called will be ineligible to run.
- No alcoholic beverages are allowed on the show site.
- There will be no refunds for entries in the event a dog and/or handler are dismissed from competition regardless of the reason for such dismissal.
- A withdrawal from the competition after the closing date due to an injury and/or illness and/or a bitch coming into season after the closing date will be eligible for a refund up to 75% of the total entry fee paid. A veterinarian's notice of injury or illness will be required for a refund.
- Ribbons will be awarded to first through fourth places in all jump heights in all classes except Chances (which is pass/fail only). Qualifying Ribbons will be awarded for those achieving a qualifying score. Each entrant will receive a Dog Toy for each day the dog is entered.
